



# **COOKIE POLICY**

Gastaldi International S.r.l. (hereinafter, "Gastaldi" or the "Controller"), represented by its legal representative *pro-tempore*, with registered office at Mura Santa Chiara, 1 - 16128 Genova (GE), provides this information regarding the technologies used on the website <u>www.gastaldi-int.it</u> (hereinafter the "Website" or "Site") and how users/data subjects accessing it (the "Users") can make informed choices regarding cookie management in accordance with current regulations.

This information is related to the Website and does not concern other websites, pages, or online services that may be accessible via hyperlinks that may be published on the Website but refer to external resources.

## **1. COOKIES**

A cookie is a small text file that is stored by the device (computer, tablet, smartphone) at the time a Website is visited by a user. A cookie can store certain information that the Site is able to read when it is accessed again on a new visit. Some of these cookies are necessary for the proper functioning of the Site, while others are useful to the visitor because they can securely store, for example, user name or language settings (where present). The advantage of having cookies installed on your pc is that you no longer need to fill in the same information each time you want to access a previously visited site.

A site uses cookies in order to provide its users with a browsing experience that is consistent with the user's preferences and so that each time you visit the Site you do not have to enter, again, the same information. Cookies are also used in order to optimize the performance of the Website: in fact, they make it easier to both navigate and quickly search for specific items within the Website.

The user can freely and at any time configure their "privacy" preferences, in relation to the use of cookies, by changing the settings of their browser.

In particular, the user can set up the so-called "private navigation", in this way the browser stops memorizing the history of the sites visited, the passwords entered, the cookies and other information that is generally collected.

Please note that, in the event that the user decides to disable all cookies (even those of a technical nature), the quality and speed of the services offered by the Site could worsen the experience on the Site.

# 2. SCOPE OF COMMUNICATION

The data described above will be processed by Gastaldi (through authorized persons) or by subjects designated as data processors (article 28 of the GDPR), in the Italian territory or in the European Union. They will also be communicated to third parties responsible for providing services connected to the activities of the Site and, in particular, to:

- WILDCARD Service s.r.l.: site hosting;
- PIXEL Studio: cookie management.

## **3. METHOD OF PROCESSING**

The data generated during navigation on the Site are processed with automated tools, for the time strictly necessary to achieve the purposes for which they were collected, after which they will be deleted or anonymized.

In any case, the data processing will take place with the aid of tools and procedures suitable for guaranteeing its security and confidentiality in compliance with the GDPR. Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.

#### 4. RIGHTS OF THE DATA SUBJECT

You may, at any time, exercise the rights referred to in articles 15-22 of the GDPR and, in particular:

- access your personal data;
- ask for the rectification and/or erasure of the information that we hold/process about you;
- object to the processing of your information;
- request a copy of the information we hold/process about you;
- withdraw consent to our processing of your information (to the extent that such processing is based on consent)
- obtain restriction of our processing of your information;
- ask for personal data you have made available to us to be transferred to you or a third party in machine-readable formats; and
- ask for data portability.

Some of these rights are not absolute: they do not always apply and exceptions may be engaged. We may, in response to a request ask you to verify your identity and to provide information that helps us to understand your request better.

The data subject also has the right to lodge a complaint with the Supervisory Authority (in Italy it is the Italian data protection authority) with registered office in Piazza Venezia 11, Rome (00187) and email protocollo@gpdp.it.
